*Our priority at Camp Bur-Mil is to provide a fun and safe atmosphere for all kids. To ensure the safety of every child we have created and use the following disciplinary policies.*

The Camp Bur-Mil Disciplinary Policy will consist of a three strike system.

Strike 1: Verbal Warning

Strike 2: Time-out during a time deemed appropriate by the camp staff (i.e. Loss of swimming time, play time, field trips etc.). The length of all time-outs will be determined by the age of the camper and severity of the offense.

Strike 3: Additional time-out and a call will be placed to the parents of the camper to discuss the situation.

In the event of a camper reaching the three strike limit more than once in a given week or on a repeated basis over several weeks, other measures will be taken including, but not limited to, parent-counselor conferences, parent-director conferences, short term suspension from camp without a refund, or permanent suspension from camp, depending on the severity and frequency of the offense.

***Camp Bur-Mil management reserves the right to deny camp enrollment at any time due to disciplinary issues to ensure the safety of all campers.***

Behaviors that warrant strikes:

1. Excessive talking at inappropriate times.
2. Use of inappropriate gestures or words.
3. Physical contact with another child, counselor, or administrator.
4. Verbal assault with another child, counselor or administrator.
5. Teasing, bullying or intimidation of any kind.
6. Vandalism to camp or park property.
7. Consistent disruption of any activity or group in which they are assigned.
8. Being disrespectful towards any other child, counselor or administrator.
9. Failure to follow the rules.
10. Failure to listen to the counselor or administrator.
11. Disruptive behavior.

Please review these policies with your child.

Camp rules will be reviewed with the campers at the beginning of camp each week.

## Camper Pick-Up & Drop-Off Policy

Camp hours are from 7:30 am to 6 pm. To discourage late pick-ups, parents arriving after 6 pm will be charged a \$1 fee per child for every minute they are late starting at 6:01 pm. Fees will be assessed by using the official clock in the day camp room. Please be prepared to pay this fee when you arrive to pick up your child.

For the safety of all the children in the camp please come into the main building to pick up your child. All campers should be dropped off and pick up in the Cedar room. Parents or Guardians need to sign their student in and out every day. If the campers are not in the room their location will be posted on the door. When picking your child up after 5 pm, please use the public entrance of the Bur-Mil Clubhouse. The Bur-Mil Park Clubhouse main entrance will be locked for your child's safety.

I further agree that in no event shall Guilford County, its managers, officers, or employees be liable for any claim, cause of action, damage, demand, expense, fine, liability, or penalty arising out of any swimming activity. The term "swimming activity" shall mean swimming in the pool, wading in the pool, playing in the pool, diving into the pool, jumping in the pool, playing in the splash pad, as well as any activity occurring on the pool deck and on the pool's property. I further agree to defend, hold harmless and indemnify Guilford County and its managers, officers from any claim, cause of action, damage, demand, expense, fine, liability or penalty arising out of my child's inability to swim.
